Format: Two rounds of 18 holes stroke play.

Eligibility: Open to all amateur women golfers 16 years of age and older as of July 23, 2018 with a verifiable handicap. No residency requirement.

Benefit: This event raises funds for Friend to Friend, a Moore County non-profit organization whose mission is to help survivors of domestic violence and sexual assault rebuild their lives.

Entry Fee: \$155 per player. The entry fee includes green fees for two days of play, cart, range balls, donation for Friend to Friend, prizes and Tuesday awards luncheon.

Practice Round: A practice round may be scheduled on July 17-19 & 22 based on availability. Fee \$25. Call Mid Pines Pro Shop: 910-692-9362 beginning July 1st

Divisions /Flights: All players, regardless of Handicap Index, have the option to play the "Championship Tees" (approximately 5600 yards) or the "Friendship Tees" (approximately 4900 yards). The overall Champion will be determined from the Championship Tees. The Friendship Tee players will be pre-flighted based on handicap index.

Field: The final field of 78 will be comprised of players with the lowest handicap indexes. Alternates are ranked according to handicap index.

Prizes: The MCWA Champion's name will be added to the tournament trophy housed in the Tufts Archive. A trophy will be awarded to the overall Champion and to the Friendship Tee player with the lowest two day score. Additional prizes will be awarded in each flight.

Player of the Year: The top two NC finishers from North Carolina or South Carolina in the championship flight receive Carolinas Golf Association Player of the Year points.

Entry Fee is \$155. An additional contribution to Friend to Friend is welcome and may be added to the entry fee. Make **checks payable to 'MCWA'** and mail with the completed entry form to:
